Scotch Pairs - First Round – Thurs 28th Oct - Best of 5 Frames

Regulation 6c - Re-arrangements are **not allowed** unless specifically requested and agreed with the committee **prior to the match**.

Regulation 6d – If re-arrangement is approved, all matches **MUST** be played **by the date of the next round draw**. Matches not played will result in both sides being removed from the competition. Exceptional circumstances can be used to allow progression as long as the committee have been so informed prior to the draw and have agreed with the reason supplied
